

# Sustainability Policy

## (Corporate Social Responsibility Policy)

Horbury recognises that sustainability is a fundamental consideration that needs to influence our approach in many aspects of our business. These aspects and our standards and aims are set out in the following statements.

### 1) Commercial Aspects

- maintain an effective and challenging corporate governance structure to continually assess, review and improve our commercial performance.

- attract and retain a diverse and talented workforce;
- promote a culture of learning, diversity and inclusion;
- give opportunities to young people to create a talent pipeline that will feed our people resource needs into the future;
- treat all workers (employees and subcontractors alike) with respect and fairness.

- do all that is practicable to ensure a safe and healthy environment for all who work for us or who may be affected by our work (see our Health and Safety Policy);
